SPECIALISED TRAINING.

Shall be carried out at District/Zonal levels on designated dates to address areas of special need:

A. FOTRS

- ST1901** - Roles and responsibilities of National Directors
ST1902 - Roles and responsibilities of Field Representatives

B. EXCO

- OT1901** - Foundation Training (Roles and Responsibilities of Chapter EXCO)
OT1902 - Operational Training for Membership Directors
OT1903 - Operational Training for Treasurers
OT1904 - Operational Training for Voice Directors.

IMPORTANT NOTES

- Zonal Training should be concluded by end of April, 2019, Area Training by end of June 2019 while Chapter Training shall be undertaken throughout the year (at least quarterly).
- National Directors should obtain ALTS Certificates, freely distributed by the National office through the Districts, before organizing training as certificates are to be issued to all participants.
- The ALTS Certificate, being the evidence of participation in training is a prime eligibility requirement for appointment/election of officers and should be issued with strict attention.
- National Directors are the Chief Trainers for their zones but they can liaise with District Training Reps to source for resource persons within and outside the district. They should take personal responsibility for the success of the training programme and ensure diligent submission of reports.
- Each National Director should submit his Training Report to his District Coordinator and forward copies to the District Training Representative for transmission to the Regional Capacity Building Coordinator and the Chairman, National Training Committee for collation, analysis and planning.
